RE: AIE HOLDER AND SIGNATORY TO THE CONSTITUENCYUWEZO FUND MANAGEMENT COMMITTEE (CUFMC) BANK ACCOUNTS

Reference is made to the Public Finance Management (Uwezo Fund) Regulations, 2014. Article (17) (1)(a-c)(2)(3) which provides that: -

(1)The sub-county accountant shall open the following bank accounts

- (d) The Uwezo Fund Main Account;
- (e) The Uwezo Fund Administration Account; and
- (f) The Uwezo Fund Loan Repayment Account


(4) The above bank accounts shall be operated by a minimum of two signatories, of whom the sub-county accountant shall be a mandatory to all bank accounts.

(5) The **Board may designate any other signatory** to the bank accounts where necessary.

The two signatories under Article (2) shall be identified and minuted as a resolution of Constituencies Uwezo Fund Management Committee.

Further to the above provisions, the Fund Account Manager shall be a second mandatory signatory to all CUFMC bank accounts, while the Sub-county Youth/Gender officer shall be the AIE holders for the fund at the Constituency level.
